PAUL VAN COTT, an attorney licensed to practice law in the
courts of the State of New York, affirms under penalty of
perjury:
1. I am an Associate Attorney for the Adirondack Park

I am an Associate Attorney for the Adirondack Park
Agency (the "Agency") and have served as the Agency's
Enforcement Counsel since 2001. I supervise the
Agency's enforcement program, including a Senior
Attorney and six enforcement officers. In this role,
I am responsible for administrative enforcement of the
Agency's laws and regulations, including in the Town of
Essex, Essex County.

- 2. I am familiar with the file in this matter and spoke by telephone on April 30, 2008 with David Lansing, Code Enforcement Officer for the Town of Essex, Essex County, concerning the status of septic systems serving Petitioner's three single family dwellings that are the subject of this proceeding. The facts stated herein are based upon my review of the file in this matter and upon information and belief based upon my conversation with Mr. Lansing.
- 3. Petitioner placed three modular single family dwellings on the subject property in Resource Management, on lands within the designated Boquet River Recreational River area, without an Agency permit. Exhibit A, which was an exhibit in the Agency's administrative enforcement proceeding, documents the approximate location of these three dwellings.
- 4. The Agency's file contains a copy of one Certificate of Occupancy issued by the Town of Essex allowing occupancy of Structure 1 on Exhibit A. According to Mr. Lansing, Certificates of Occupancy have not been issued for Structures 2 and 3 on Exhibit A. Thus, only Structure 1 is authorized by the Town of Essex for occupancy as of this date.

- Agency Enforcement Committee's March 25, 2008

 Determination, the Committee found that Lewis Family

 Farm, Inc. had installed a common septic system for

 the three single family dwellings. This finding was

 supported by ¶ 14 of the January 17, 2008 Affidavit of

 Barbara Lewis and its Exhibits E and F, who stated

 that the three single family dwellings were "serviced

 by a common septic system and leach field". See,

 Exhibit B hereto. It is also supported by the July

 23, 2007 Affidavit of John Quinn and its Exhibit A

 consisting of Petitioner's partial application to the

 Agency for permits for its three single family

 dwellings. See, Exhibit C hereto.
- 6. In its determination, the Committee required

 Petitioner to obtain an Agency permit prior to any
 occupancy of the single family dwellings. As part of
 its review of Petitioner's permit application, Agency
 staff would require Petitioner to demonstrate that the
 alleged, common septic system (or any septic system
 serving any of the single family dwellings) complies
 with New York State Department of Health and
 Adirondack Park Agency standards and guidelines. To
 ensure that Petitioner provided the necessary

ensure that Petitioner provided the necessary information in this regard, the Enforcement Committee, in ¶ 2(b) of its determination, expressly required Petitioner to provide an evaluation of whether the alleged, common septic system for the three single family dwellings complies with those standards and guidelines.

- 7. It is my understanding from Mr. Lansing that there is not a common septic system serving the three single family dwellings. Rather, Mr. Lansing advised me that the septic system serving Structure 1 is actually the same septic system that served the pre-1973 single family dwelling that has been removed from the subject property. Agency staff have not reviewed that septic system for compliance with New York State Department of Health and Adirondack Park Agency standards and guidelines. Based on my understanding of the size of that system from Mr. Lansing, it would not meet New York State Department of Health standards and guidelines as a common septic system for three single family dwellings.
- 8. According to Mr. Lansing, septic systems for the other two single family dwellings, or a common system to serve all three of the single family dwellings, has

Petitioner has, however, applied for and obtained permits for installing new septic systems for all three single family dwellings from the Town of Essex.

See, Exhibit D.

9. Prior to authorizing use of a pre-existing septic system, the Agency would typically require an engineering evaluation to determine whether or not it complies with New York State Department of Health and Adirondack Park Agency requirements. This is to ensure that the septic system is designed to be adequately protective of the environment. The Town of Essex does not apply consider Adirondack Park Agency septic requirements when reviewing septic systems.
